## A NEW YEAR FOR ELKDOM DAWNS

As always, we move forward. Daylight Saving Time returns on March 14, spring starts on March 20, and the new fiscal year of the Elks begins on April 1. You should have received your dues

renewal statement for 2021-2022 in the mail. This year, these notices were sent out by the Grand Lodge, a change initiated to improve our record keeping and save the local Lodges time and money. Your payments still go directly to the Madison Elks Lodge, either by check in the reply envelope furnished, or by credit card, debit card, or echeck at the online link,



https://search.revopay.com/elkslodge. Once you have paid, your membership and key cards will be mailed to you by the Secretary, beginning sometime in mid-March. We will notify you when the key card locks at the Lodge have been changed – sometime in early April, so until then, please hang onto your old (purple) key card as well as your new (red) key card.

We hope you will be able to pay your dues soon as it helps keep your Lodge financially healthy. We also remind you to consider making one or more of the optional contributions suggested on the dues statement, including a tax-deductible donation to the Elks National Foundation (ENF). Its mission is to help Elks build stronger communities and fulfills this pledge by investing in communities where Elks live and work, including our own. Last year the ENF donated more than \$8,000 in grants to the Madison Elks Lodge. Also, donations to the Lodge's Maintenance and Equipment Fund are greatly appreciated. Our 56-year-old home has been in much need of attention the past year, and we hope to keep it in good shape for many years to come.

Widow(er)s of members will receive a letter from the Secretary toward the end of the month asking them if they would like to receive an identification and key cards to access the facilities of the Lodge during the 2021-2022 year.

If you have not yet paid your 2020-2021 dues, please do so prior to March 31, 2021. In compliance with the statutes and bylaws of our Order, delinquent members will be dropped on that date. The Secretary will send a letter to any dropped members notifying them of their status and their right to reinstatement if the application is made within 60 days. Reinstatement requires the payment of both delinquent and current dues and approval by a majority vote at the next membership meeting. (Continued on next page)

# MADISON PUBLIC HEALTH ORDER UPDATED

Indoor events or meetings where food or drink is not offered are limited to 350 individuals. Indoor events or meetings where food or drink is offered are limited to 150 individuals. Face coverings and social distancing are required. Outdoor gatherings are limited to 500 individuals and social distancing is required. Face coverings are required for outdoor gatherings larger than 50 individuals. Restaurants may open up to 50% of their capacity and face coverings are required when not eating or drinking. Tables and chairs must ensure at least six feet physical distancing between customers who are not members of the same household or living unit.

### THE OLD LODGE

Our current home, lakeside at 711 Jenifer Street, opened its doors 56 years ago this month. By then, however, the Madison Elks Lodge already had a long history in our community. Founded in 1898, Lodge #410 was not the first Elks club in our state. That honor goes to Milwaukee Lodge #46, founded in 1886.

In 1901, renowned architectural firm of Claude & Starck designed what would become the first permanent home for the Madison Elks with an estimated construction cost of \$20,000 (more than \$3 million today).

On October 14, 1901, the *Wisconsin State Journal* reported that the Elks would lay the cornerstone for its new clubhouse in an article headed "Elks Planning Weird Ceremony." The definite date had not been decided, but was estimated to be on October 23, assuming all work on the new building at the corner of West Doty Street and Monona Avenue had been completed. What the newspaper found "weird" about the ceremony was that it would be held at 11 p.m. To be placed in the cornerstone at that time would be copies of that days two Madison daily papers, a list of officers, stockholders and directors of the Lodge, and 11 new pennies to symbolize the hour the stone was laid.

The ceremony was actually held the night of Friday, October 24 following a banquet at the Capital House. At half past ten, led by Marshal Henry C. Baker and the Elks Band, two columns of the "sons of the forest" marched down Monona Avenue to their new home on the corner. Under five arc lights with over 1,000 in attendance, the solemn ritual proceeded. Exalted

Ruler Mathias Breckheimer opened the ceremony exactly at 11 p.m. by striking a gong 11 times followed by the Eleven O'Clock Toast. The large cornerstone was then swung into place by Mat Swank, contractor T. C. McCarthy's best mason, and Mr. Breckheimer smoothed the first mortar over it using a silver trowel.

The new structure was completed in 1902. On the first floor to the left of the entrance was a "handsome parlor" furnished with heavy oak and leather chairs. Adjacent were a card room, library, and café. Also, on the ground floor were a billiards room and buffet (bar). These rooms were divided by large folding doors so they could be opened and incorporated into one large space for banquets and parties. Upstairs was the theater, a large room designated for Lodge meetings and balls. Above its stage was the inscription "The faults of our brothers we write in the sand."

This address served its members well until it was decided in the early 1960s to move on and build a new Lodge. The structure was razed along with its neighbor, the Grand Army of the Republic (GAR) Hall, in June of 1964, replaced by a parking lot.




### 711 JENIFER STREET

In 1962, the Building Committee of the Madison Elks Lodge, chaired by Kenneth Sullivan, recommended sale of the clubhouse on Monona Avenue to the Bank of Madison for \$250,000 and the construction of a new Lodge in the 700 block of Jenifer St. Sullivan noted that the new two-level, lakeside facility with ample parking and piers would cost an estimated \$400,000. "That our present facilities are not conducive to a profitable operation is evidenced by the loss of \$64,000 in our club and lodge operation from 1948 to 1962," stated Sullivan in a letter to the members. Part of the agreement was that Lodge #410 would continue to occupy its current property after the closing of the transaction for at least eight months for no charge. The membership voted on the proposal at its monthly membership meeting on September 26. Exalter Ruler James Joyce announced that it was approved by "a substantial majority" and that construction of the new building at 711 Jenifer Street was expected to commence "soon."

After several unanticipated delays including rising costs, Exalter Ruler Arthur Flood announced a ground-breaking ceremony would be held on April 2, 1964, at 2 p.m. Honored guests included Mayor Henry Reynolds and the only living charter member of Lodge #410, Ernest Burmeister. The members had just raised their dues for the first time in 10 years from \$30 to \$40. Two month later, the demolition of the Monona Avenue clubhouse began.

The first ceremony held in the still uncompleted Lodge was on Saturday, March 13, 1965, when a record 73 new members were initiated. This exceeded the goal of 67 new members to commemorate the 67<sup>th</sup> year of Elkdom in Madison. Exalted Ruler Flood announced that current membership now totaled 1,256. On Sunday, March 28 Madison Elks under the leadership of its newly elected Exalter Ruler, Albert E. Koch, held a cornerstone laying ceremony to mark the official opening of its new facility. It would take several more months to complete the lower level and landscaping.
